AN ORDINANCE CREATING THE OFFICE OF COUNTY ROAD SUPERINTENDENT AND FIXING THE SALARY AND COMPENSATION FOR SAME, AND PROVIDING FOR OTHER ASSISTANTS AND EMPLOYEES OF THE ROAD

#### COMMISSIONER.

THE BOARD OF SUPERVIS. ORS OF THE COUNTY OF SO-LANO DO ORDAIN AS FOL-

SECTION 1. The office of COUNTY ROAD SUPERIN-TENDENT in Solano County is hereby created. The County Road Superintendent shall have supervision of the work of road construction and repair under the direction of the Road Commissioner, and shall work out of the office, and in the department. of the Road Commissioner.
